General

Information We Collect

Discount Power collects Personal Information that you submit voluntarily and knowingly through the Site. Discount Power may also collect market-related information, which may include Personal Information concerning market trends and activities impacting its business. This information may include contract terms, financial information and other information for the purpose of market analysis and strategic planning. When you visit the Site, certain information may also be automatically collected and stored on Discount Power’s web servers, including but not limited to, your internet protocol (“IP”) address, domain name, browser type and operating system. Discount Power also from time to time uses “cookie” technology on the Site. “Cookies” are small text files a website can use to recognize repeat users, facilitate the user’s ongoing access to and use of the Site and track usage behavior of, for example, the Web pages you visit.

Collection/Use and Disclosure of Information

Discount Power collects your Personal Information when establishing a business relationship with you, including enrollment for services provided by Discount Power, and for obtaining credit approval for the establishment of such services. Discount Power will not sell or provide your information to unaffiliated companies for commercial purposes unrelated to the business of Discount Power. Discount Power may disclose your Personal Information if such disclosure is necessary (a) to comply with required applicable law or regulatory requirements (b) to respond to an inquiry or provide you with a service which you have requested (c) to implement Discount Power’s terms of service (d) to protect the rights, property or personal safety of another Discount Power user, any member of the public or Discount Power (e) to comply with a change of ownership of all or part of Discount Power through some form of merger, purchase, sale, lease or amalgamation or other form of business combination, provided that the parties are bound by appropriate agreements or obligations which require them to use or disclose your Personal Information in a manner consistent with the use and disclosure provisions of the Privacy Policy, unless you consent otherwise and (f) pursuant to your consent.

Security
